### **B.Sc. (Final Year) Practical Examination: Detailed Instructions/Guidelines for Examinees**

**(Applicable to B.Sc. Final Year Students who are eligible to appear in TEE June 2020)**

1. B.Sc. Practical examination will be conducted at seven examination centres under IGNOU Regional Centre, Noida and the learners from few study centres have been clubbed with other centres for appearing in B.Sc. practical exam as per following details:

2. There will be separate bilingual question papers for each course. The time given to answer a 4 Credits course is 1 hour and for a 2 Credits course is 30 minutes. A gap of 15 minutes will be kept between any two consecutive examinations. 3. For a 4-credit course, the examinee would have to attempt 20 out of 25 objective type or short answer questions and for a 2-credit course, 10 out of 15. Each question would carry 2.5 marks. The maximum marks for 4-credit and 2-credit courses would be 50 and 25, respectively.

4. No hall ticket will be issued for appearing in B.Sc. Practical Examination, however examinee must be in possession of valid IGNOU Identity Card during the examination and should not carry Mobile Phone inside the Examination Hall at the time of Examination.
5. The Examination Centers will implement the Social Distancing and other measures as per Government of India guidelines in current scenario of Covid-19 to ensure health and safety of the students.
6. Students are also required to adhere to the guidelines and maintain the Social Distancing and hygiene to ensure safety and health of their own and the fellow students.
7. Examinees may note that there can be a possibility of last minute change of Examination Centre due to Covid-19 situation or any other reason. You are advised to keep yourself updated in this regard by checking the website of IGNOU RC Noida on a daily basis.
8. Please check your Enrolment Number in the Exam centre wise List of Examinees for B.Sc. 9. Examinee must ensure that his/her registration is valid for the course(s) in which he/she is appearing in the exam. In case it is found at a later stage that the registration was not valid, his/her result will not be declared by the University.
10. The learners will be allowed to appear in the courses mentioned against their Enrolment number in the Exam Centre wise Examinee List, however in case the courses mentioned are different from the ones in which he/she is registered, they must carry the proof of their registration status i.e. print out of the registration details available at the link: <http://admission.ignou.ac.in/changeadmdata/admissionstatusnew.asp>
11. If there is any learner who is eligible to appear in the B.Sc. Practical Examination, however his/her name does not appear in the list uploaded at above link, he/she may write to [rcnoida@ignou.ac.in](mailto:rcnoida@ignou.ac.in) minimum three days prior to the exam i.e. latest by 17<sup>th</sup> October, 2020. However, learners must ensure that their registration is valid for the courses in which he/she wishes to appear. While writing email, learners must mention their Enrolment number, course codes, study centre code and contact number.
