It has come to the notice of the Regional Centre that some unauthorized persons/agencies are approaching the students of IGNOU through social media platforms (whatsapp group/messages/emails/phone calls etc.), asking them to make the payment for admission / re-registration etc. through fraudulent payment links.

As per IGNOU Public Notice dated 28.02.2024, it is once again clarified that the University has not authorized any person or agency to receive payment on its behalf for any purpose whatsoever. Students are advised to visit only the official website of IGNOU (<https://www.ignou.ac.in/>) and follow the relevant links available on the website for making payments for admission/re-registration fee etc.

Emails related to admission / re-registration etc. are sent by the University HQ and the Regional Center NOIDA only through the official email IDs (ending with @ignou.ac.in or @samarth.ac.in / @samarth.edu.in). Emails received from any other email ID asking for payment are to be treated as fake and should be reported to the police.

IGNOU shall not be responsible for payments made through any such fraudulent payment link or website. Students are advised to be cautious and not fall prey to such fraudsters.


Public Advisory

It is informed that IGNOU never authorizes any person for collecting money towards Examination Fee, Issue of Duplicate Grade card and Degree, Transcript, Verification of certificates, Project & Practical Fees Revaluation, Photocopy of Answer sheet etc. The learners are advised to pay fee related to above activities through official website of IGNOU '<http://ignou.ac.in>' only.

All the learners are further advised to remain alert and vigilant and prevent themselves from being cheated and share details with local Police Authorities for stringent action under the law.

All the Regional Centres of IGNOU are also advised to sensitize the learners registered with them on the issue. The University will not be responsible for any such fraudulent transactions and/or consequences arising out of it.
