 - a. On Login Page, kindly fill all the required fields details and then Click on Login button.
 - b. You may apply for online Re-evaluation and Copy of Answer Script, once the TEE Result is declared and uploaded on the IGNOU website.
 - c. After filling the mandatory information, click the "Save" button to generate Payment Link.
 - d. Student be facilitate with scanned copy of his/her answer script through Email-ID provided in the Online Form or the Photocopy of Answerscript be sent through Post.
 - e. Reevaluation and copy of Answerscripts is not available for Following Exam for Multiple Choice Questions (MCQ) type and conducted on OMR sheets

NOTIFICATION

With the approval of the competent authority, the services regarding Re-evaluation and supply of photocopy of answer scripts have been made online. Accordingly, Indian students desiring to avail the services may apply online and payment may be made through credit card/debit card/Net Banking. This online facility is not applicable for International students.

1. Rules and Regulation for Re-evaluation of Answer Scripts:

- (i) The fees for Re-evaluation of answer script per course is Rs.750/-.
- (ii) The request for Re-evaluation by the student must be made within one month of declaration of his/her results.
- (iii) The date of declaration of result will be calculated from the date on which the result(s) are placed on IGNOU website.
- (iv) After re-evaluation, the better of two scores of original marks/grades and the marks/grades after re-evaluation will be considered.
- (v) The result of re-evaluation will be made available on the IGNOU website www.ignou.ac.in. In case, if a student was already issued final Statement of Marks/Grade Card and there is an increase in the marks/grades in the re-evaluation, a revised Statement of Marks/Grade Card will be issued to the student.
- (vi) The minimum time required for re-evaluation shall be 30 days from the date of submission of application.
- (vii) Re-evaluation is permissible in Term-end Theory Examination only and not in any other component such as Practical Examination, Lab Courses, Assignment, Project, Workshop, Seminar, Extended Campus Programme, Internship, Dissertation, Viva-voce, Teaching Practice, etc.
